Policy Making in an uncertain world: Mitigating risks, maximising opportunities

The island of Ireland is having to confront great challenges and changes more often than not driven by external influences. In addition the island is likely to see population growth driven by internal dynamics in both jurisdictions which could conceivably see the population increase to over 8 million people by 2050. In other words the population will finally surpass the population on the island pre-famine. How can policy makers confront these likely scenarios, ever increasing international instability and the pressures to provide for effective public services with a mainly urbanised and educated population in both jurisdictions. In an era of "new politics" in both parts of the island what is needed to enable both public services address such changes positively?

In this Seminar, leading policy experts will identify those challenges likely to drive future priorities. It will look at some of the policy legacies requiring a new perspective while also taking on board international influences which will be critical drivers in how future governments deliver their political commitments.

Who should attend?

The seminar will be of interest to key policy makers across the full sphere of public policy on the island of Ireland. Likely participants will include senior civil servants, local government chief executives, state agency executives, policy advisors to the political parties as well as key contributors to policy development from the social partners. Peter Clinch Peter Clinch is an economist and holds the chair of Jean Monnet Professor of European Economic Integration as well as a Chair in Public Policy at University College Dublin. He is also UCD Vice-President for Innovation. His academic specialisms are sustainable economic growth and environmental economics.

Martin Frazer Martin Frazer is Secretary General at the Department of An Taoiseach and Secretary General to the Government.

Declan Kearney Declan Kearney is a specialist in human resource management, leadership, the management of change and public sector restructuring and reform. He is a founding member of the PPAN. He was Associate Professor in Public Management at the Institute of Public Administration in Maastricht following which he became Head of Public Sector Consulting at the international consultancy firm Hay Group. Ronan Lyons Dr Ronan Lyons is Assistant Professor of Economics at Trinity College Dublin. Stephen is a weekly columnist for the Sunday Business Post and, in addition to 4 books, about 25 journal articles and winning around 2 million euro in research funding, he has also written policy pieces for publications like the Harvard Business Review, Foreign Affairs, and VoxEU.
